Leave a gift in your will for Response



Thank you for considering leaving a gift in your Will to Response. We can take you through the steps to leave a gift in your Will, making it easier than ever.

What is a Gift in a Will?

A gift in your will—often called a legacy or bequest—is a way of making a lasting contribution. You can specify a fixed amount, a percentage of your estate, or even the balance of your estate after other bequests have been made. Whatever your choice, your legacy will help Response continue its important work for years to come.

Types of Gifts:

There are three main types of gift you can leave:

Residuary gift

A residuary gift is a percentage or share of your estate after any gifts, payments, taxes or costs have been subtracted. Because this gift is a percentage or share of your estate you don't need to worry if your financial situation changes.

Pecuniary gift

This is a set amount of money, the value of which may decrease over time due to inflation.

Specific gift

A particular item, this could be anything from a piece of jewellery to furniture or property.

Establishing the value of your estate

Think about the value of your estate including property, valuables such as jewellery or art, investments, stocks and shares, insurance and pensions and any debts such as loans, outstanding mortgage or money owed. Leaving a gift to charity in your Will can help reduce, or even remove, the tax burden on your estate. There are also a number of measures that may help reduce your estate's Inheritance Tax liability. For more advice, check the HMRC website or speak to your solicitor.

Choosing your Executors and Guardians

You will need to appoint the individuals responsible for ensuring that your wishes are fulfilled. Known as 'Executors', they will be named in your Will and have a legal responsibility to make sure your wishes are carried out. They can be a solicitor who charges a fee, or a friend or family member. Although a friend or family member can't charge for being your Executor, they may wish to pay a solicitor to help them. It's a good idea to name at least two people as Executors. Before doing so, check they are happy for you to do this.

If you are a parent, you should decide who you want to be your children's legal guardians if both parents die when the children are under 18 (or under 16 in Scotland).

Appointing a Solicitor

It's important to ask a legal professional to draw up your Will to ensure your wishes are properly carried out. It is particularly important if your Will is not straightforward. This might be the case if:

• you have young children or children with a former partner

• You want to leave money to someone who cannot care for themselves

• You own a property or investments with someone who is not your husband, wife or civil partner

• You own a property overseas

• You own a business

Can I alter my Will if my circumstances change?

You can easily amend your will with a codicil—a legally binding document that works alongside your existing will.

Are Wills expensive?

The cost of Wills will vary depending on your individual needs, but having a valid Will in place is a valuable investment into you and your loved one's future.

How long does it take to write a Will?

Drafting a simple will might not take very long, but if your estate is more complex and you require professional input- the process could extend over days/week. I've chosen to leave a gift in my will to Response because I want to make sure that people struggling with their mental health always have somewhere to turn.
